For the purposes of logistics, promotion and marketing, preference is given to those vendors who are able to attend all of our market days. Vendors must commit to attending a **minimum of 8 of our 12** market days. If you are not able to attend any market day to which you have committed – due to unforeseen circumstances, you must notify us by noon on the preceding Friday so that we can post your absence on our social media sites.

Fees

Table fees are \$10 per week. This is used for marketing and promotion including your roadside vendor sign, as well as our membership in the provincial Farmers' Market organization. We are all volunteers.

SET UP AND LOCATION

Vendors have several options for set up and location for this 2022 season. Some vendors will set up their booths outdoors, preferably at their driveways along the Kempt Head/Hillside Boularderie Road. (Vendors are responsible for their own tables, etc.) If you do not have a driveway along the road, or you prefer to be indoors, the options are the upper hall of the Ross Ferry Fire Hall (max 3-4 vendors) or the Southside Boularderie Fire Hall. You may prefer to set up down at the Ross Ferry Marine Park, or with another vendor. **You must provide the coordinator with the exact location so that it can be approved and included on our vendor map.**

Hours of Operation

The hours of the market are 12 noon to 3pm Sunday afternoons.

Vendors are to be set-up and open for business at noon. If you sell-out during the afternoon, ensure that you place a visible "Sold Out" notice on both sides of the vendor sign we have provided to you. Also, post it on the Ross Ferry Farmgate Group Facebook page so that the other vendors know as well.

Craft Vendor Guidelines and Regulations

- All items sold must be hand made by the vendor.
- Vendors may not sell craft items that violate copyright and trademark laws. (For example, incorporating the Walt Disney logo or characters like Yoda from Star Wars into your product.) Vendors may not sell or resell items they have not created themselves. (For example, reselling commercially manufactured jewelry purchased through an online wholesaler.)
- Craft vendors are juried for quality and originality. Photos can be submitted with your application.

Note to Cosmetic Vendors

If selling soaps, salves, and other cosmetic products:

- You have read and agree to follow Health Canada's *Guidelines for Cosmetics Manufacturers, Importers, and Distributors* and that you are in compliance.
- For each product, you have submitted a *Cosmetic Notification Form* to Health Canada.
- You have read and agree to follow Health Canada's *Labeling of Cosmetics* guidelines.

By participating in the 2022 farm gate market, you consent to having your product information/photos of products used in our promotional materials and website. We have a profile of each vendor on our website. Please send us photos of new items you add during the season. Customers may want to contact you directly.
